Code of Conduct for School Transport

While the learners make use of the school transport, please adhere to the following requirements:

1. Learners are to remain seated and seatbelts are to be worn around the waist at all times whilst the bus is in motion. Drivers will ensure that seatbelts are securely fastened and adjusted before beginning the journey.
2. No standing up or walking around the in the bus.
3. No eating or drinking is permitted.
4. No part of the body may protrude from the bus.
5. Learners are expected to use appropriate language on the bus, no vulgar or foul words will be tolerated.
6. No form of bullying will be tolerated.
7. Learners are to be respectful towards the driver and bus monitor as well as the other occupants of the bus.
8. Learners may not make alternative pick up or drop off arrangements with the Driver without the necessary written permission from parents.
9. Learners are responsible for their own possessions.
10. Learners may not have access to the radio to play their music.
11. Learners may not cause any damage to the seats of any other part of the bus.

By signing or initialling this Transport Agreement, the Parents / Guardian agrees to ensuring that the Learner complies with the Code of Conduct and to educate their child/ren regarding safety during a bus trip. Failure to comply with the Code of Conduct could result in your child/ren being removed from this service. The Parents/Guardian, jointly and severally, have absolute responsibility for the payment of any Transport Fees applicable to the Learner(s) using this service. The Parents/Guardian also acknowledge that fees are payable in advance. If there is any provision in this agreement that the Parent/Gaurdian does not understand, they are obliged to ask for an explanation before signing.
